

## Select Internet Recharter 2.0 Updates

- When ACH fails, allowing unit to resubmit and select another method of payment
- Changed validation message for Webelos working on Arrow of Light
- Updated recharter confirmation email
- Added provision for Special Needs Youth who are beyond Program Age to pass recharter validation process
- New Recharter Posted Confirmation Image
- Remove requirement for Member ID to add new IH, Tiger Cub Adult, and Lion Adult Partner
- Change Validation for Unit has less than 2 paid youths from Warning to Error
- When ACH payment confirmation fails, revert recharter status to Initiated vs. On Hold or Waiting
- Create page for unit treasurers to confirm microdeposits if they do not receive confirmation email from WePay
- Explain how to 2 linked units must pay online from the same bank account
- YPT non-compliance now an Error for the unit
- Improved recharter support for Exploring Posts and Clubs
- Email approval will be sent to both Unit Key 3 and Key 3 Delegate
- Demo Tool for Commissioners (aka Sandbox)
- Micro-deposits confirmed via a website, not by email
- Marking prepaid youth and adults on recharter paperwork



## **Select My. Scouting Enhancements**

- Launch a new My. Scouting landing page with a constant Menu displayed
- Add Social Media links to the My.Scouting pages
- Enhance login and log-out function to speed up the process
- Add "Betty-Bot", the online helper to all pages of My. Scouting
- Added a unit search tool to the Organization Navigator tool used in many MyST applications
- Allow an adult in Online Registration to multiple into more than one position within the same District
- Non-Unit Renewals can now add Scout's Life magazine to the renewal
- Updated recharter confirmation email
- Add YPT status and Gender to the Application Manager
- Add the YPT email option to application manager
- Added a new training report -Specific Training Course Report to Training Manager
- Create a new "Detail Cub Scout Membership Totals Report
- Change the application flow for Online Applications to provide a better user experience
- Changed all Advancement Reports to now read from the Scoutbook Data base
- Now Showing unit gender for Multiple Validation in Recharter Plus
- For Internet Rechartering, Allow the Council to Change the "COR signature" to yes if the unit is "Waiting Status"



## **Select Registrar Tools Enhancements**

- Add the Coming Soon / New Unit Job Aid to the user Guide
- Add a new "Missing Parent/Guardian" report to the Registrar Tools tab
- Lower the minimum age requirement to 18 for functional positions like 'Registration Support"
- Publish the Position Roles of functionality Matrix what roles give you what access User Guide
- In recharter+, adding additional registrations to a charter, you can now add multiples
- Allow leaders to multiple between Posts and Clubs
- Create a new position Called "Council Unit Representative" (similar to COR)
- Registrar can now change the effective date of a transfer
- New Tool to allow online renewal of Non-Unit Registrants (with email invitation)
- Allow Exploring Participants to register using Online Registration
- Allow Exploring Participants to register using Online Registration
- Allow Unit participants to be over 21 if the disabilities setting is used
- Add a report to Registrar Tools of the details from Units using Internet Rechartering (Copy of IR paperwork)
