



BRAD SIMMONS EAGLE SCOUT OF EXTRAORDINARY SERVICE AWARD



1. HISTORY – The Brad Simmons Eagle of Extraordinary Service Scout Award was created in 2024 to honor the memory of a Distinguished Eagle Scout, former Council President, and longtime Program Director for the Mackinaw Island Scout Service Corp, Bradley Simmons.

2. PURPOSE - The intent of this award is to give recognition to an Eagle Scout, like Brad Simmons, who has exhibited the very highest level of servant leadership, character, and scout spirit. They must exhibit the tenets of the scout law to a unique degree, especially points 4, 5, and 6: friendly, courteous, and kind. Up to 4 awards may be presented annually within the Michigan Crossroads Council.

3. ELIGIBILITY - To be eligible for this award, a Scout must have earned the rank of Eagle Scout with the most recently completed Eagle Scout class Year.

4. NOMINATIONS – Any Eagle Scout from the past years' Eagle Scout Class can be nominated for this award. Self-nominations will be accepted. Deadline for nominations is due by May 17th of each year. Nominations are available statewide and will only be considered if they are e-mailed to: nesa@michiganscouting.org

5. AWARD PRESENTATION - The NESAC Committee, using its own prerogative, may award a maximum of four awards per year. The names of recipients will be given to the Staff Adviser to secure medals and make them available for presentation at a public event. Events may include the Building Character Celebration, the Eagle Recognition Dinner or any other Michigan Crossroads Council or District event designated by the NESAC Committee.
